77.01 **DEFINITIONS.** The following terms are defined for use in this chapter.

- 1. "Off road utility vehicle" means a motorized vehicle with four (4) or morenonhighway tires that is limited in engine displacement to less than one thousandfive hundred (1,500) cubic centimeters and in total dry weight to not more than two thousand (2,000) pounds and that has a seat that is of bucket or bench design not intended to be straddled by the operator, and a steering wheel or control leversfor control. Vehicles designed for the primary purpose of recreation, such as dunebuggies and recreational side by sides, shall not fit this definition and are not allowed under this section. The chief of police shall have the final say on whethera vehicle meets this definition. These vehicles shall be referred to as ORV or ORVs in this code.
- 2. Golf Carts shall be referred to as GC or GCs in this code
- **77.02 ORV EQUIPMENT REQUIREMENTS.** Any ORV in the City of Marengo, shall be equipped as required by Section 321I.10, 321I.12, and 321I.13 of the Code of Iowa, including but not limited to: muffler, headlight, tail light, and brakes.
- **77.03 DRIVER'S LICENSE REQUIRED.** No person shall operate an ORV or GC onany public highway, street, road or alley within the corporate limits of the city unless such person has a valid driver's license.

Persons between age sixteen (16) and eighteen (18) who have passed an All-Terrain Vehicle (ATV) or Off Road Vehicle (ORV) educational course approved by the State of Iowa may operate an ORV within the corporate limits of the city. Proof of course completion should be kept with the operator while the vehicle is in use.

77.04 PROOF OF INSURANCE. The owner of every ORV or GC being operated upon city streets and alleys shall have in effect liability insurance covering the ORV or GC in the same limits as required of automobiles by the financial responsibility provisions of chapter 321A of the Code of Iowa.

- 77.05 **OPERATION RESTRICTIONS OF VEHICLES.** The following restrictions shall apply to the operation of all vehicles covered under this chapter.
 - 1. ORV or GCs may be operated upon the public highways, streets, roads and alleys within the corporate limits of the city. ORV or GCs operation shall be permitted on trails subject to the location restrictions in section 77.06 of this code. ORV, GCs shall not be operated upon sidewalks unless the operator is engaged in snow removal or sidewalk maintenance activities.
 - 2. If seatbelts are available, they must be used by all occupants. No person may ride upon the lap of another.
 - 3. No person may ride on an ORV or GC on any portion not designed to carry passengers. No person may stand on or ride in the cargo area of an off road utility vehicle. No golf cart or ORV shall carry more passengers than for which the vehicle was designed for.
 - 4. Unattended Vehicles and Parking. No person shall leave an ORV or GC unattended on public property while the motor is running or the keys are in the ignition switch.
 - 5. No golf cart, ATV or UTV shall be operated while under the influence of intoxicating liquor, narcotics or habit-forming drugs.
- **77.06 LOCATION RESTRICTIONS.** The following location restrictions shall applyto the operation of all vehicles covered under this chapter.
 - 1. City Streets. Registered ORV or GCs may be operated upon Streets under the jurisdiction and within the corporate limits of the City of Marengo pursuant to the restrictions and requirements contained in this chapter.
 - 2. Trails. ORV or GCs shall not be operated on any recreational, bike or walking trail unless the trail is specifically designated to allow use of off road utility vehicles.
 - 3. City Parks and other land owned by the City of Marengo. ORV or GCs shall not be operated in City parks or upon other city owned land unless for a special public event authorized by the Chief of Police. Approval for operation incity parks must be sought prior to the event and will be granted on an individualbasis by the Chief of Police. ORV or GCs covered in this chapter may enter the Lions Field Facility.
- 77.07 **REGISTRATION, LICENSING, FEES, AND INSPECTION.** No city registration, licensing, fees or inspection required.
- **77.08 PENALTIES.** Any person who is found to have violated any provision of this chapter shall be subject to a municipal fine of one hundred dollars (\$100.00) plus surcharge and costs.
- **77.09 GOLF CART REQUIREMENTS.** GCs shall be equipped with a slow moving vehicle sign and a bicycle safety flag. The carts shall be equipped with adequate brakes.
- 77.10 GOLF CART HOURS. Golf carts shall be allowed on the streets only between sunrise and sunset.
- **77.11 SPEED.** No golf carts shall be operated on any City street at a speed in excess of 25 miles per hour.
